Over the last few years, we have had to think outside the box in order to be able to keep providing the best possible education for our pupils at a time of very severe cuts to our budgets. We have found new ideas to make our money go further and sought new sources of funding. You have helped us in so many ways. We are extremely grateful: your support turns a good school into an outstanding learning *community*. But changes in our funding are putting our extra-curricular provision at risk and it is these extra opportunities outside the classroom that lift a good education and transform it into something extraordinary.
